5. Committee Reports
a. Communications:

## b. Fundraising:

- Annual Fund: Banner for progress to date. Will add stickers for percentages, reprint after Auction. Quick guide banner as well. Quick guide lives on website already, maybe add rocket?
- Task list for Fundraising has been created - includes Annual Fund, Grade Level Socials. Nicole will meet with Carrie, Lyllis to add Jogathon and Auction tasks.
- Working on list of accomplishments from 2016-2017 - paras, computers, water fountains, etc. Ideally information would be provided at Grade Level Socials. This year, will include in a letter promoting Colorado Gives Day (12/5) - will send out through My School Anywhere, maybe also include in Thursday Folders?
■ Match fund of \$10K has been assembled for Colorado Gives day this year. Fliers will be posted around the school. Would like to add Colorado Gives button to website - ok with Anne.
■ Annual fund goal has been reduced from budgeted $\$ 70 \mathrm{~K}$ to $\$ 55 \mathrm{~K}$ due to Jogathon success \& higher fundraising goal for The Auction.
- Auction: Lyllis requesting money up front for a caterer. \$4K-\$5K. Looking for corporate sponsorships for the school as a whole - expect to find a sponsor that would ultimately cover this amount.
- Sponsorships would have to be connected with PTO - would manage funds. Could be advertised via banners, ePost, website, Thursday folders, t-shirts, yearbook, fundraising banners
- Amy will put together proposal for sponsorships, email Anne \& Colin, bring to December meeting
- Also need advance funding of $\$ 597$ for online bidding tool.
- Motion to approve $\$ 6000$ in additional funding for Auction expenses. Motion passed unanimously.
- Polaris gear sales: No representatives present - moved to next meeting.
- ACTION ITEM: A separate gear committee meeting will be held to further discuss gear options, timing, and inventory issues.
